WHAT IT MEANS NOT TO HAVE MERCANTILE TAX IN STOCKERTOWN

Somewhere back in the year 1987, the State Legislature, in its infinite wisdom, declared that municipalities that did not have a Mercantile Tax provision in place by November 1988, would not be able to put that provision in place at a later date. For reasons unknown to this Editor, Officials of Stockertown in 1988 chose not to establish a mercantile tax, and thereby forfeited that option forever.

What all that means to you as a resident, is quite simple. The Borough derives income for its general operating budget from several sources: franchise fees, permits, licenses, fines, impact fees from new development, rental fees, liquid fuels distribution (Act 655), interest income and taxes. The tax portion is 86% of all revenue, followed by interest income of 8%, liquid fuel distribution of 3%, and rental income of 2%.

Without the additional income from businesses within our boundaries, the residents provide most of the operating capital. No blame or animosity should be placed on the businesses of the Borough, however, as the decision of 1988 was not made by, nor included, them. They are simply benefactors of the decision. We need to embrace our local businesses, as they have, on their own, been quite generous.

A "Five-Year-And-Beyond Plan" for the Borough is being developed, which has never been done before. The goal of planning for the future needs of the Borough within the structure of its revenues is very challenging. Because of the lack of a mercantile tax, the main source of operating revenue unfairly falls directly on the residents.

FORKS EMERGENCY SQUAD

On April 1st of this year, Forks Emergency Squad reorganized after some internal problems, and re-opened their Basic Life Support Service (BLS) to Forks Township and Stockertown. They have one transport van and three emergency vehicles, one of which is dedicated to Forks Township and Stockertown 24/7. They

answered 60 calls in April, 107 in May and as of June 12th, they have responded to 55 calls. It appears that they are on their way to recovery and the BLS/ALS coverage that they used to provide. Borough Council wishes them success. Their success will insure that our residents have the best EMS coverage available.

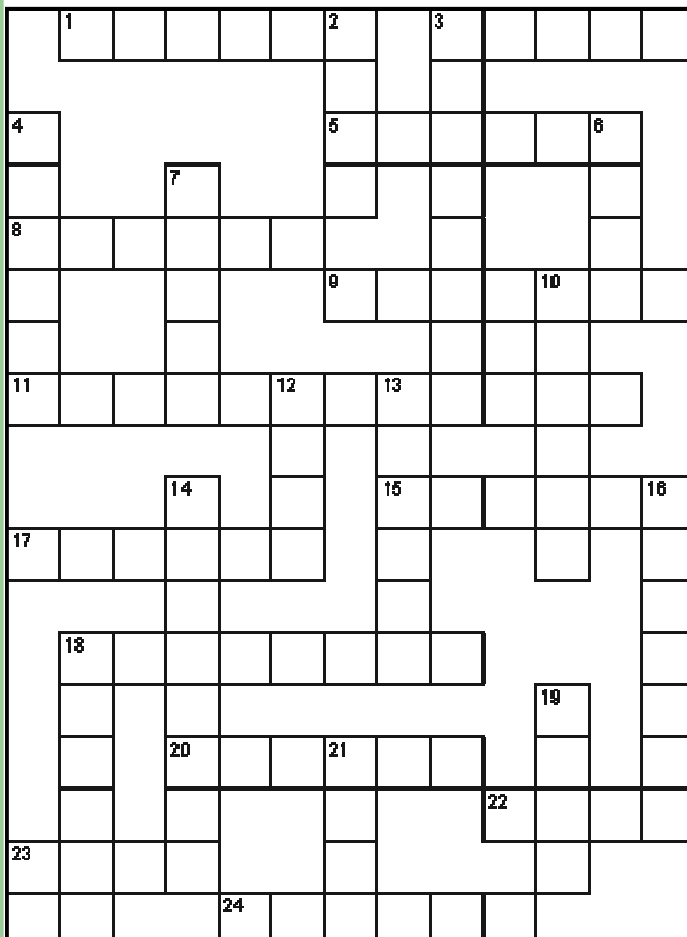
