

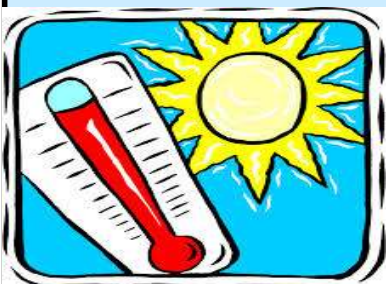

## Police Department

Members of the Stockertown Police Department have voted to unionize and become affiliated with Teamsters Local 773. The Borough is preparing to engage in collective

bargaining negotiations with the newly formed union in the near future. There will be significant costs associated with the bargaining process and ongoing union activities.

## Long's Development Notice

Notice: Council has voted 7-0 to install STOP signs on the North and South corners of Faith Ave. creating a four way stop at the intersection of Faith and Jubilee. The speed limit within the development remains at 25 MPH although residents of the community continue to drive through the intersection at speeds well

above that limit. The intersection is the main connector to the development as well as a school bus stop. Please be mindful of the speed limit and new signage there as well as throughout the development for the safety and protection of all of pedestrians, especially the children. Violators will be ticketed.

## Rails to Trails Update

The Trail section between Center Street and Industrial Blvd is nearing completion. However there is edging, fencing and other landscaping to be done before it is opened to the public. Barricades are placed at either end of the trail to contain construction

equipment as well as to prevent entrance until all parts of the project are completed. Please DO NOT enter the trail area either on foot, bike, motorized vehicle or any other mode of transport until the trail has been officially opened for public use.

~ Please have identification tags on your pets, (cats and dogs), and make every effort to protect and contain them.

~ By ordinance, all pets must be on a leash when on Borough or Public property. If your dog should defecate on public property you are responsible to clean it up immediately and dispose of it in a trash receptacle.

~ For residents wanting library access, Easton Public Library and Mary Meuser Library will provide library cards to the residents of Stockertown. The Borough will reimburse residents when a receipt is provided to the Secretary.

~ Nazareth Ambulance Corp is our Emergency Service provider. Forks Fire is our Fire Protection service. Stockertown is included in their yearly membership requests. Your donation helps fund training, operational costs and purchase equipment which helps protect you.

~ It is unlawful to discharge ground water, pool or sump pump water into the Borough's sewer system. Anyone found in violation will be prosecuted.

~ The recycling center is for Stockertown residents only! Please flatten cardboard, tie paper bundles and deposit all recyclables in the containers provided on Lafevre Road.

~ We no longer accept branches to chip. Please bundle and tie all branches and put with weekly trash pick-up.

~ It is unlawful to throw grass, branches, pine needles or other debris ANYWHERE over on or around the bank of the creek. We provide full service trash collection for the disposal of yard waste

~ Stockertown has a Fire and Burn Ordinance. It eliminates all open burning within the Borough limits except for recreational fires. "Recreational fire" means any fire ignited in the confines of a fire ring, chimenea, fireplace, or patio burning device and used only for recreational pleasure. All recreational fires must include a metal covering device or spark arrestor with spaces of not more than one-half (1/2") inch, over the entire surface of the containerized fire. Prohibited fires include burning of any refuse, construction waste, hazardous material, or trees, brush, stumps, leaves, and grass clippings.

~ It is so important that residents don't put improper materials into the sewer system. Nothing but toilet waste, kitchen and bath water should ever enter your sewer line! NOT grease, diapers, feminine products, dead animals, or cloth items. The Waste Water Treatment Plant is not a landfill, but a delicate balance of biological processes.



### A note to parents ~

There are multiple bodies of water within the Borough including retention ponds, fishing ponds, and creeks. Please reinforce the dangers of still or running water with your kids.
