

RULES AND REGULATIONS

These rules are designed to help you have a safe and enjoyable visit while protecting our park resources and ensuring enjoyable use of the park by others.

ALCOHOLIC BEVERAGES

IT IS PROHIBITED TO BE INTOXICATED, TO CONSUME OR POSSESS ANY AND ALL ALCOHOLIC BEVERAGES ON PARK GROUNDS.

DESTRUCTION OF PROPERTY

IT IS PROHIBITED TO WRITE, PAINT, CARVE OR IN ANY WAY DEFACE OR DAMAGE ANY TREE, BENCH, PUMP, WATER FIXTURE, BATHROOM OR ANY OTHER STRUCTURE ON PARK GROUNDS. THIS INCLUDES THE PULLING OF OR BREAKING OFF OF ANY FLOWERS, FRUIT, PLANTS, TREES, BRANCHES, GRASS OR TURF.

DISORDERLY CONDUCT

IT IS PROHIBITED TO COMMIT ANY DISORDERLY OR IMMORAL ACT OR UTTER ANY LOUD, PROFANE, INDECENT OR OTHERWISE OFFENSIVE LANGUAGE OR ACT IN ANY WAY SO AS TO ENDANGER SELF OR ANYONE IN OR AROUND PARK GROUNDS.

DOGS & OTHER PETS

DOGS AND OTHER PETS MUST BE KEPT ON A LEASH AND ARE NOT PERMITTED TO RUN AT LARGE. THE PET OWNER IS RESPONSIBLE FOR DISPOSING OF ANY WASTE PRODUCED BY THE PET.

FIRES

DO NOT SET FIRES EXCEPT IN DESIGNATED COOKING AREAS. OPEN FIRES ARE EXPRESSLY PROHIBITED EXCEPT FOR DESIGNATED BARBECUE PITS THAT MAY BE PROVIDED IN THE PARK. NEVER THROW LIGHTED MATCHES, BURNING CIGARETTES OR OTHER FLAMMABLE MATERIAL IN ANY PARK AREA.

FIREWORKS

IT IS PROHIBITED TO POSSESS FIREWORKS, ROCKETS OR MISSILES ON PARK PROPERTY.

HOURS OF OPERATION

THE PARK IS OPEN DAILY FROM DAYLIGHT TO 10:00 P.M. FROM MAY 15TH THROUGH OCTOBER 15TH.

LITTER

IT IS PROHIBITED TO THROW, DEPOSIT OR DRAIN ANY SUBSTANCE OF ANY KIND OR TO DEPOSIT PAPER, VEGETATION OR ANY TYPE OF REFUSE ANYWHERE ON PARK GROUNDS EXCEPT IN THE PROPER RECEPTACLES PROVIDED. IT IS PROHIBITED TO DUMP HOUSEHOLD GARBAGE ON PARK GROUNDS.

MOTORIZED VEHICLES

IT IS PROHIBITED TO DRIVE OR RIDE AUTOMOBILES, SNOWMOBILES, TRUCKS, BUSES OR ANY MECHANICAL OR POWERED EQUIPMENT ON PARK GROUNDS. THIS EXCLUDES ANY HANDICAPPED MOTORIZED VEHICLES.

PARK EQUIPMENT

USE OF THE PARK EQUIPMENT IS AT YOUR OWN RISK.

PARKING

PARKING IS PROVIDED FOR THE HANDICAPPED INSIDE THE PARK. THOSE PERSONS IN CHARGE OF GROUPS USING THE PARK MAY DRIVE THEIR VEHICLES INTO THE PARK TO LOAD AND UNLOAD ONLY. OTHERWISE, ALL VEHICLES MUST BE MOVED OUTSIDE THE PARK TO THE PARKING AREA ON THE OTHER SIDE OF THE BRIDGE. ALL PARKING OR DRIVING IN THE PARK WILL BE PROHIBITED ON RAINY DAYS.

IT IS PROHIBITED TO PARK AUTOMOBILES, TRAILERS, CARTS, WAGONS, SLEDS, CYCLES OR ANY OTHER VEHICLE OR MEANS OF CONVEYANCE IN ANY AREA NOT CLEARLY DESIGNATED FOR SUCH USE.

PAVILION RENTALS

A DEPOSIT WILL BE REQUIRED **WITH ALL RESERVATIONS** IN THE AMOUNT OF \$50.00 AND MAY BE REFUNDED AFTER USE OF THE PARK IF:

- 1, THERE WAS NO APPARENT DAMAGE AND/OR MISUSE OF BOROUGH PROPERTY AND/OR EQUIPMENT.
- 2, THE BOROUGH WAS NOTIFIED AT LEAST SEVEN (7) DAYS IN ADVANCE OF CANCELLATION OF SAID RESERVATION.

IN ADDITION TO THE DEPOSIT, THE RENTAL FEE FOR RESIDENTS IS \$25.00 AND NON-RESIDENTS IS \$50.00. YOUR RESERVATION WILL BE SECURED UPON PAYMENT OF THE APPROPRIATE FEES.

PAVILION LIGHTS

THE LIGHT SWITCH FOR THE PAVILION IS LOCATED UNDER THE ELECTRICAL BOX ON THE CENTER POST OF THE PAVILION. PLEASE BE SURE THAT THE LIGHTS ON THE PAVILION, AS WELL AS THE BATHROOM LIGHTS ARE TURNED OFF BEFORE LEAVING THE PARK.

PICNIC RESTRICTIONS

PICNICKERS MUST LEAVE THE AREA IN A CLEAN CONDITION. KEEPING THE RESTROOMS AND WASHROOMS IN A NEAT AND SANITARY CONDITION, AND REPOSITION ANY PICNIC TABLES, BENCHES, OR EQUIPMENT THAT WERE MOVED TO THEIR ORIGINAL POSITIONS.

PLEASE REMEMBER TO TURN OFF PAVILION LIGHTS BEFORE LEAVING.

ELECTRICAL OUTLETS ARE PROVIDED FOR APPLIANCES ONLY. PLEASE REFRAIN FROM OVERLOADING A CIRCUIT.

REMOVAL OF WATER FROM THE CREEK IS PROHIBITED.

SOLICITATION

IT IS PROHIBITED TO SOLICIT SUBSCRIPTIONS OF ANY KIND IN OR AROUND PARK GROUNDS.

TRESPASSING

PLEASE DO NOT TRESPASS ON ADJACENT PRIVATE LAND WITHOUT PERMISSION FROM THE LANDOWNER. THOSE FOUND TRESPASSING ARE SUBJECT TO PROSECUTION BY THE LANDOWNER.
