### Public Comment

- Earl Kocher, of 300 Old Easton Road, stated that he received a summons pursuant to the Abandoned Vehicle Ordinance. At a previous meeting, he had discussed with Council, and was advised that Council would speak with Chief Soloe. Mr. Kocher was upset that he had not received a response, prior to the issuance of a summons. Ms. Richard stated that she had discussed it with Chief Soloe, and that it is a police matter.
- Mr. Kocher also indicated his displeasure regarding minutes from Borough Council meetings. He stated that he has repeatedly requested the minutes during meetings, but that he doesn't receive them timely. He complained about the Administrative staff "covering for each other". Ms. Richard advised that they have other duties to attend to, and preparing the minutes is not always the top priority. She suggested that Mr. Kocher call the office ahead of time to inquire if the minutes are ready to be printed and disseminated. She also suggested setting a timeframe by which the minutes should be completed following each meeting. Mr. Zaboy recommended that copies of the minutes be charged for as per the fee schedule. Ms. Richard stated she would take it under advisement.
- Carol Kish, of 564 LeFevre Road complained about the horrible condition of LeFevre Road near the Plainfield Township line, as well as by the pond near the gun club. Leon Heller, of 569 Horseshoe Drive, also voiced his concerns over damage being done to their vehicles, costing them money for repairs. Ms. Richard responded that Council is researching ways to pay for the engineering and construction costs associated with resurfacing roadways throughout the Borough. She understands that LeFevre Road has no base and requires an extensive overhaul. She advised that projects with a cost over \$10,000.00 must be opened up for public bidding. Paul Zaboy, Jr. stated that he would have Public Works staff start patching the larger holes on Thursday, January 5<sup>th</sup>, but that the smaller holes would not patch well. Paul Zaboy, Sr. advised that any construction would have to be done under the



“prevailing wage calculation”, which would increase the cost by a factor of 30%. He also stated that the Borough is looking into grant fund availability, but using grants would prolong the entire process. Ms. Richard updated her earlier statement regarding Borough purchasing, increasing the baseline figure for bidding to \$18,500.00, pursuant to recent changes to the Borough Code (Agenda Item).

- Eric Wenzelberger, of 111 Center Street, inquired if Council was planning to adopt any Rules of Order. Ms. Richard stated that Council was not presently seeking to adopt any Rules of Order.
- Richard Wagner, of 100 Winona Street, inquired about the recreational trail project, citing the placement of stakes along the trailbed. Mr. Zaboy advised that the surveyor has provided the survey data to the trail design firm, URDC, and that he anticipates construction along the trail to occur between Spring and Summer 2012. Mr. Zaboy also answered that our Public Works staff will be doing some of the minor construction work, including the building of benches and tables for placement along the trail. The majority of the construction would be accomplished by an outside contractor.
- Joe Gold, of 201 Main Street, asked about the trail crossing Industrial Drive. Mr. Zaboy advised that the original plan would have the people reaching Industrial along the trail to travel east, cross Main Street, continue north or South, then cross Main Street again and return west to the trail. He discussed the Chrin signalization project and indicated that new traffic lights are going to be placed at the Route 33 exit ramps, and that the traffic lights would be synchronized to assist in pedestrian activities. Mr. Zaboy also mentioned the “safety island” idea that was proposed at one planning meeting, and that the Borough is still awaiting PennDOT approval.
- Eric Wenzelberger inquired about the current status of the wastewater treatment plant. Ms. Richard said she was hoping for Mobile Dredging to come in soon, based upon the weather, to perform the sludge removal. Mr. Wenzelberger then asked why the sewer engineer, Jeff Morgan, does not come before Council to discuss the facility. Ms. Richard stated that would cost the Borough more money to have Mr. Morgan appear at Council meetings.

#### **Secretary/Treasurer report**

- **Motion** by Carl Zito, seconded by Paul Zaboy, Sr., to approve the minutes of the December 28, 2011 budget meeting as corrected. Motion carried unopposed.
- Ms. Richard discussed each of the Borough’s total bank balances per fund.

#### **Council Comments**

- Carl Zito stated that the lower clip on the US Flag at the memorial is broken and needs replacing. He also stated that the monument light fixture and glass was broken and required repair. Paul Zaboy, Jr. stated that the glass for that model light fixture is no longer available. We would have to purchase custom tempered glass or buy brand new light fixtures to replace the existing ones. Paul Zaboy, Sr. stated it would likely be cheaper to replace the glass, and suggested buying a spare pane.

#### **Mayoral Report**

- None.

**Agenda Items**

- Ms. Richard planned to discuss the changes to the Borough Code with respect to the increased bidding and telephonic quote cost minimums. She did this during Public Comment with respect to the repairs to LeFevre Road.

**New, Old, or Unfinished Business**

- Mr. Asteak advised that the Codification was nearly complete. The latest ordinances have been provided to General Code to be incorporated; a process which should take three or four weeks. He expected to advertise the adoption ordinance soon.
- Mr. Zaboy asked PJ to give an update on the Emergency Management Trailer. The trailer is ready to go, now that the generator, purchased in 2010, is working well. PJ advised that he has installed an air compressor and emergency lights. He is in the process of adding emergency communications equipment, but stated that noise from the generator may hamper the effectiveness of the communications gear. The tarp, which had been missing straps and had been ripped, was recently repairs at Kaplan's for \$50.00.
- Ms. Richard advised that she has a tentative offer on the fire truck from a fire company with a \$30,000.00 budget.
- Earl Kocher requested a copy of the approved minutes.

**Adjournment**

- **Motion** by Paul Zaboy, Sr., seconded by Jack Fatzinger, to adjourn the meeting. Motion carried unopposed at 8:24 pm.
