**Secretary / Treasurer Report**

- **Motion** by Kathleen Zdonowski, Seconded by Cindy Hower to approve Council Meeting Minutes of April 15, 2024 with noted correction. Motion carried unopposed.
- **Motion** by Cindy Hower, Seconded by Joe Gosnell to approve accounts payable for the General Fund through May 6, 2024. There were no entries for Sewer Fund. Motion carried unopposed.

**Mayor's Report:**

- Mayor Rosemarie Wenzelberger reported on a seminar entitled Older and Wiser to be presented on May 16 & May 23<sup>rd</sup> sponsored by State Representative Ann Flood. Topics being covered are Living Wills, Powers of Attorney, Wills and Guardianships, and is open to the public.

- No update at this time on the widening project of Lincoln Avenue.
- Resident Kay Morris expressed concern about crossing Main Street at the Post Office. Penn Dot has not approved a crosswalk to date, but the request could be inquired into again. A suggestion was made to ask Representative Flood for her assistance in this matter.
