

**THE BOROUGH OF STOCKERTOWN HELD A MEETING ON WEDNESDAY,
DECEMBER 15, 2010, AT 7:30 PM AT BOROUGH HALL.**

Attendance

- Councilors present were Ms. Amy Richard, Council President, Mr. Paul Zaboy, Vice President, Mr. Jack Fatzinger, Ms. Cindy Hower, Mr. Carl Zito, Mr. A. Joseph Gosnell and Mayor Sherman Metzger. Mrs. Rosemarie Wenzelberger and Solicitor Gary Asteak were not present.

The meeting was called to order at 7:30 PM by President Amy Richard followed by the Pledge of Allegiance

Public Comment

- Eric Wenzelberger – 115 Center Street, Commented that the Christmas party was very nice and Santa did a great job! Attendance was up and all had a good time!

New Business

- Council reviewed and approved Borough 2011 Calendar to be published.
- Council reviewed and approved the contact list for 2011 to be published.
- Discussion was held regarding the Stockertown Rod & Gun Club request for the Borough to copy 6400 pages for their yearly mailing. In the past, the Borough has done some copy work for the Rod and Gun Club. Due to the volume of the request, the age and condition of the copier, the use of staff to complete such request and end of year obligations, Council concluded that the Borough does not have the appropriate time nor funding to honor such a request. The Rod and Gun Club will be notified.
- Paul Zaboy informed Council, chemical tanks were delivered last week, to the WWTP. One of the tanks delivered was not what was ordered but a replacement tank was delivered. Installment of the new tank is scheduled for Thursday, December 16, 2010.
- Two generators were purchased at the Federal Surplus in Harrisburg by Paul Zaboy and Charles Davis on December 8, 2010, totaling \$1,200.00. They also purchased blankets for Emergency Management and plan to price spare Motors for the generators all of which will be picked up next week on December 23rd.
- Discussion was held on the 2011 General Fund Budget and 2011 Sewer Budget. Both budgets are balanced and ready to be advertised.
- A scheduled meeting will be held on December 30, 2010 for final approval.

- **Motion** by Carl Zito, seconded by Joseph Gosnell to advertise the Sewer Budget.
