

THE BOROUGH OF STOCKERTOWN HELD A MEETING ON MONDAY, JUNE 21, 2010, AT 7:30 PM AT BOROUGH HALL.

Attendance

- Councilors present were Mr. Jack Fatzinger, Mr. Carl Zito, Mr. Paul Zaboy, Ms. Amy Richard, Ms. Cindy Hower, and Mr. A. Joseph Gosnell. Rosemarie Wenzelberger was not present.
- Also present were Mayor Metzger, John Soloe, and Gary Asteak
- Patrolman Vrael was on duty to preserve the meeting.

Meeting called to order at 7:30 PM by President Amy Richard followed by the Pledge of Allegiance

Public Comment –

- Earl Kocher, 300 Old Easton Road, questioned the hour and one half spent in executive session during the April 19, 2010 meeting and he objected to the way a vote was made after the executive session. He noted the repetition of a similar vote in the minutes of May 17, 2010. Amy Richard noted that most of the executive session in question was used to review applicants for the Borough Secretary position. She will examine the minutes for the discrepancy and report her findings. Mr. Kocher mentioned the condition of the roads within the Borough.

Secretary Report

- Motion by Paul Zaboy, second by Carl Zito to approve the minutes of June 7th with noted corrections to the Resolution Number and wording of the Sherry Acevedo comments.

Mayoral Report (Sherman Metzger)

- The mayor attended the ceremony for Eagle Scout Matthew Kelly. He also attended a conference on electricity supply at Lafayette College.

Public Works Report (Charles Davis)

- To buy 350 – 400 gallons of oil from Fuel Cell for the Emergency Services Building at \$2.17 per gallon. Mr. Davis claims that the generator at the WWTP can't be repaired and he wants permission to go to Harrisburg to purchase a new generator from \$2,000 – \$2,400 depending on availability. He also asked permission to buy 40 blankets at a price of \$5.00 each. **Motion** by Paul Zaboy, second by Jack Fatzinger to purchase 40 blankets from the Emergency Management budget. Motion carried unanimously. **Motion** by Paul Zaboy, second by Jack Fatzinger to purchase a generator for the WWTP not to exceed \$3,000. Motion carried unanimously. A trip will be scheduled in the near future.

Police Report (John Soloe)

- There was no written report. Mr. Soloe said the Borough Police are "all over the strikers" at Hercules.

Zoning Report (John Soloe)

- There was no report.

Solicitor's Report (Gary Asteak)

- There was no report.

Fire Report

- A Quarterly report was distributed to Council.

Agenda Items

- Corrections to the Public Works Department job description were reviewed and discussed. **Motion** by Paul Zaboy, second by Carl Zito to approve the Public Works Job Description with corrections previously made. Motion carried unanimously. A meeting will be scheduled for the Public Works Department to review the new Employee Policy and Job Descriptions.
- A contract renewal was presented from Signal Services to service the street lights on Main and Industrial Blvd. The contract would run from July 1, 2010 through June 30, 2012 with a yearly fee of \$525. **Motion** by Joe Gosnell, second by Paul Zaboy to accept the service contract of Signal Services for the two year term at \$525 per year. Motion carried unanimously.

Old Business

- Paul Zaboy is trying to get some clarification with the sidewalk issue on Industrial Blvd. as part of the Rails to Trails route.

New Business

- There will be a Zoning Hearing On July 1, 2010 at 7:00PM for the Chumas Property (Shell Station) on Industrial Blvd. seeking relief to add two additional structures to the property. The potential use would be retail, restaurant, or office space.

Executive Session

- **Motion** by Carl Zito, second by Paul Zaboy to leave Regular session and enter into executive session at 8:29PM for personnel issues.
- **Motion** by Paul Zaboy, second by Jack Fatzinger to exit Executive session and return to Regular session at 9:00PM.

Adjournment

- **Motion** by Jack Fatzinger, second by Carl Zito to adjourn the meeting at 9:07 PM. The motion carried unanimously.
