REGULATIONS & COMPLIANCE

- No solicitation is permitted before **9:00 AM** or after **7:00 PM**.
 - No solicitation permitted on Sundays or Borough holidays.
 - Solicitors must **present / display permit visibly** at all times.
 - No solicitation at any residence displaying a **"No Solicitation" sign**.
 - No Parking on PENNDOT Roads.
 - No Illegal Parking.

FINES FOR NON-COMPLIANCE

- **Operating without a permit:** \$600 per occurrence, and/or imprisonment
 - **Violating permitted hours or signage restrictions:** \$600 per occurrence and/or imprisonment
 - **Failure to present permit upon request by resident or Borough official:** \$600 and/or imprisonment
 - **Subsequent violations:** up to \$600 and revocation of permit and/or imprisonment
 - **Other Violations:** up to \$600 per occurrence and/or imprisonment

No license shall be issued under this article until an application has been made as above required, and the proper fee.

If such person shall also be required to obtain a license from any county officer, state or federal officer, he must provide a copy of such license, when making such application.

No person licensed as a peddler under this article shall occupy any fixed location upon any of the streets, alleys or sidewalks of the Borough for the purpose of peddling, with or without any stand or counter.

No peddler licensed as a peddler under this article shall park any vehicle upon any of the streets or alleys of the Borough in order to sort, rearrange or clean any of his goods, wares or merchandise, nor may any such person place or deposit any refuse upon any of such streets, or alleys, nor may any such person maintain or keep a street or curbstome market by parking any vehicle upon any street or alley in the Borough for longer than necessary in order to sell therefrom to persons residing in the immediate vicinity.

No person licensed as a peddler under this article shall hawk or cry his wares upon any of the streets or sidewalks of the Borough, nor shall he use any loudspeaker or horn or any other device for the announcing his presence by which the public is annoyed.

No peddler shall engage in selling any product not mentioned upon such license.

No peddler shall engage in selling any product nor wares, nor solicitation at any residence or place of business with signs displaying "no solicitation" or "no trespassing".
