## ORDINANCE NO. 2018-1

### AN ORDINANCE

AMENDING THE CODE OF ORDINANCES OF THE BOROUGH OF STOCKERTOWN, CHAPTER 228, VEHICLES AND TRAFFIC, ARTICLE I, SPEED LIMITS, ARTICLE II, PARKING TIME LIMITS, ARTICLE V, STOP INTERSECTIONS DESIGNATED, ARTICLE VI, SNOW EMERGENCY ROUTES, ESTABLISHMENT OF NO PARKING ZONES, SIGNS, AND PROVIDING FOR VIOLATIONS AND PENALTIES THEREFOR.

BE IT ENACTED AND ORDAINED by the Borough Council of the Borough of Stockertown, County of Northampton, Commonwealth of Pennsylvania, that the Borough of Stockertown Code of Ordinances is hereby amended as follows:

## Chapter 228

#### **VEHICLES AND TRAFFIC**

**SECTION 1:** Article I, Section 228-2, Speed limits designated, is hereby amended to provide as follows:

Speed limits upon highways and streets located within the Borough of Stockertown are established as follows:

Name of Street	Speed Limit (mph)	Location
State Route 191	35	Between Main Street and Upper Nazareth Township border
State Route 191	35	Between Main Street and Plainfield Township border
Bushkill Street	35	Between Center Street and the Bushkill Creek
Main Street	35	Between Center Street and the Forks Township border
Main Street	35	Between Center Street and the intersection of Main Street and Route 191

**SECTION 2:** Article I, Section 228-3, Violations and penalties, is hereby amended to provide as follows:

Any person violating any of the provisions of this article shall, upon summary conviction before a Magisterial District Judge, be sentenced to pay a fine of \$30 and costs of prosecution and, in default of the payment, shall undergo imprisonment of not more than five days.

**SECTION 3:** Article II, Section 228-4, Parking time limits, is hereby repealed.

**SECTION 4:** Article II, Section 228-5, Violations and penalties, is hereby amended to provide as follows:

Any person who shall violate any provision of this article shall, upon conviction thereof, be sentenced to pay a fine of \$30 and costs of prosecution and, in default of payment of such fine and costs, to imprisonment for not more than five days. Provided: It shall be the duty of the peace officers of the Borough to report to the Mayor all violations of any provisions of this article, the license number of the vehicle involved in such violation, the location where such violation took place, the time of such violation, and any other facts that might be necessary in order to secure a clear understanding of the circumstances attending such violation.

**SECTION 5:** Article V, Section 228-16, Stop intersections designated, is hereby amended to provide as follows:

**SECTION 6:** Article VI, Section 228-20, Snow emergency routes, is hereby repealed.

**SECTION 7:** Article VI, Section 228-24, Establishment of no-parking zones, is hereby amended to provide as follows:

The parking of motor vehicles, or the placement of other objects within the rights-of-way of the following locations is hereby prohibited:

Name of Street	Side	Location
Bushkill Street	Both	From Main Street South to dead end
Center Street	North	From Main Street West to Bushkill Street
Commerce Way	Both	From Hercules Drive North to end of Commerce Way
LeFevre Road	Both	From Main Street East to Plainfield Boundary Line
Main Street	Both	From Forks Boundary Line to Plainfield Boundary Line (entire length)
Hercules Drive	Both	From Commerce Drive to dead end at Route 33
Winona Street	Both	From Bushkill Street East for a distance of $1/10$ a mile
Industrial Blvd.	Both	From Main Street to Upper Nazareth Boundary
Station Street	Both	From Bushkill Street to Winona Street

**SECTION 8:** Article VI, Section 228-26, Violations and penalties, is hereby amended to provide as follows:

Any person who violates any provisions of this article shall pay a fine of \$30 per day per violation. Provided: It shall be the duty of the Police Officers or of parking enforcement personnel of the Borough to report to the Police Department of the Borough indicating, in each case: the section violated; the license number of the vehicle involved in the violation; the location where the violation took place; the date and time of such violation; and such other facts the officer might deem necessary in order to secure a clear understanding of the circumstances attending the violation of this article. The notice shall contain instructions to the owner or driver of the vehicle that if he/she will report to the Police Department or the Municipal Building at 209 Main Street and pay the sum of \$30 within five days after the time of the notice, that act will save the violator from prosecution and from payment of the fine and costs proscribed in this section. In the event of any prosecution under this article, a default of the payment of any fines

and costs required will require the violator to undergo imprisonment in Northampton County Prison for not more than five days.

**SECTION 9:** If any section, subsection, paragraph, sentence, clause or portion or part of this Ordinance shall be declared to be invalid or unconstitutional by any Court of record or of competent jurisdiction, then, in that event, the remaining portions of this Ordinance shall remain unaffected and remain in full force and effect.

**SECTION 10:** This Ordinance shall be effective immediately.
