YOUR SEWER BILL EXPLAINED

Please note there will be an additional \$50.00 added to this bill and the next two quarterly sewer bills.

Traditionally you are billed around the 15th of the first month following the past three months of sewer service.

During the year 2006, you received only three quarterly sewer billings instead of four. The quarter you are being billed for currently is actually two quarters behind your actual service instead of one. Council unwittingly allowed a former council member, through his insistence, to handle a large portion of the Borough's finances including the sewer billing. The billing remained on schedule until the 4th quarter of 2005, which was not billed until 2/17/06. The 1st quarter of 2006 was

was billed on 9/15/06. The third quarter of 06 was billed 1/05/07. The result of this sporadic billing is that the billing is 2 quarters behind. It's very probable that most residents never missed the 4th billing in 2006. If the toilet flushed and the sink drained, life was good. However..... In order to collect this extra quarter of revenue, we have elected to spread the \$150.00 over the remaining three quarters of 2008 by adding \$50.00 to each remaining quarter. You will be given the entire quarter to make your payment without late charges, in an effort to minimize the impact. We are sorry for the inconvenience. We have made many changes to the Borough's accounting structure in 2007 to eliminate the reoccurrence of this billed on 6/16/06. The 2nd quarter of 06 or other types of inaccurate accounting.

STOCKERTOWN PUBLIC WORKS DEPARTMENT

Most of you already know our Public Works Department Staff, but for those who don't; meet Royce Getz, longtime employee and Charles Davis our Department Supervisor. Charlie came to the department in 2003. He was Maintenance Supervisor for 5 years at Majestic Co., and 31 years at Behr Paint. Royce retired from Beth. Steel and has been working for the Borough for more than 37 years.

These men along with additional part time employees are responsible for the care and maintenance of the Borough's property; including the parks, the Municipal Hall grounds, the sewer plant grounds, the Rod and Gun Club ball field, all the buildings, streets, right-of-ways, stream banks, street signs, traffic lights, machinery, tools and vehicles. They plow our roads in the winter and they cut and trim our grass in the summer. They clean, they paint, they build, they repair and they

will always have lots to do. Charlie is also our sewer plant operator. He takes and records water samples 7 days a week, cleans the grinders, monitors the water intake, pond levels and a host of other activities. Their hard work and dedication is truly appreciated.


